Location is within Black Bear Habitat area &amp; in close proximity to High Priority/Density/NSO Habitat areas.

Location is within Rule 411a Surface Water Intermediate Buffer.

Location is approximately 379 yards from Beaver Creek.

While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1. Equipment - Flowline heating insulation open ended with a CA date of 10/17/2023
2. Tanks & Berms - Secondary containment liner needs maintenance with a CA date of 10/30/2023

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
