Note- there appeared to be cultivated millet on the eastern topsoil stockpile, which should not persist. If this turns out to be Wild proso millet, then this is problematic and is a List C Colorado noxious weed.

Once the stockpile has sufficient establishment of desirable vegetation, then it will meet Rule 1002.c. standards.

The new introduced invasive annual grass species, Cereal rye, is still persisting and observed throughout portions of the interim reclamation area.**

Operator has failed to submit an Interim Reclamation Plan that details the action plan to successfully implement and establish the reported seed mixture and how the Operator will control and manage the introduced grass species, Cereal rye.

Operator has failed to conduct reclamation in accordance with Rule 1003.e.(2); therefore, interim reclamation remains out of compliance.

Corrective Action **Operator shall submit the required Interim Reclamation Plan as detailed within FIR Doc.#697504724. In addition, the Interim Reclamation Plan shall detail how to also control and manage Cereal rye.**
