Comment: This location does not comply with Rule 1004. During this inspection, Staff observed that road base and medium sized cobble remains throughout the former access road and well location. Additionally, areas of bare/exposed soils and undesirable vegetation (CO List C Noxious weed - Cheatgrass, and kochia) were observed in the reclaimed areas. This location requires additional weed management and revegetation activities. Refer to attached inspection photos.
