On Tuesday, 10/17/2023, Inspector Kirby Burchett, conducted a follow up field inspection at Caerus Piceance LLC on the Piceance Creek Unit F31-19G, Location #333832, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District & Wildlife Management Plan with Black Bear, High Priority, NSO, and Density Habitat regulations.

Production equipment is shared with the USA-Piceance Creek 52-19G well on the same pad with Location ID #311865.

Follow up inspection in response to compliance issues observed during Inspection #702501710 on 8/8/23. One corrective action has not been resolved:

1. No sign at tank battery. Due date remains 9/8/23.
