Comment: The perennial vegetation has not yet established at the location. Vegetation transects were performed documenting insufficient vegetation cover. The west side of the location consists mostly of undesirable weeds and there is an area along the reclaimed access road which consists mostly of weeds. Additional reseeding will need to be performed in the fall season. Corrective action will remain out of compliance until completed.
