HAS DETERMINED THE SURFACE LOCATION OF THE BUNKER 8-6H WELL TO BE 2110' FSL, 2275' FWL, AS MEASURED AT NINETY (90) DEGREES FROM THE SECTION LINES OF SECTION 29, TOWNSHIP 5 NORTH, RANGE 68 WEST AND THE BOTTOM HOLE LOCATION TO BE 1025' FNL, 677' FWL, AS MEASURED AT NINETY (90) DEGREES FROM THE SECTION LINES OF SECTION 30, TOWNSHIP 5 NORTH, RANGE 68 WEST, OF THE 6TH PRINCIPAL MERIDIAN, LARIMER COUNTY, COLORADO.
