Drilled 36' of 7 7/8" hole and ran 28.5' of 8 5/8" surface casing. Drilled 6 1/4" hole to 240' and encountered minor surface water. Pulled out 7" and reamed from 6 1/4" hole to 7 7/8". Ran 4 joints (140') of 7" casing. Could not drill ahead with air. Pulled 7" casing. Back-filled hole with dirt and cuttings. Level and clean up location.

This location has been cleaned up and is now ready for inspection.
