On 05/25/2022, Reclamation Specialist O'Malley conducted a follow up inspection to #702800192 at Chevron USA Inc's Wilson Creek Unit-62N94W /2SWNE Location #314497 in Rio Blanco County, Colorado. West Environmental Supervisor, Alex Fischer was also present for the inspection. Previous inspection #702800192 observed erosion control BMPs on the Location are missing or insufficient. Inspector required Operator to install or repair required BMPs per Rule 1002.f by 6/10/22. It was observed in this inspection straw wattles are present along the downslope perimeter of the Location. This corrective action has been addressed. Spoil piles from the hillside downslope of the Location were removed as of 09/05/2023.
