Caerus responded to this via our Answer to Notice of Alleged Violation No. 403483534 dated 8/29/2023. The majority landowner has not responded to our requests for communication; we did, however, identify and communicate with a second, minor landowner of the access road, and we are meeting this week to have a landowner variance signed. Variance will be submitted next week by 11/10/2023, assuming our meeting is held as planned. We also treated the weeds on 8/09/2023, however, per our Answer to the NOAV and due to the majority land owner taking control of and expanding the footprint of the location without agreement from Caerus, Caerus has requested that the commission consider the majority landowner the responsible party, freeing Caerus from responsibility to manage weeds and conduct additional reclamation at this location. In our Answer to the

NOAV, Caerus asked that all corrective actions at this location, including additional final reclamation work, additional weed management work, and submittal of a weed management schedule, be stayed until our responsible party defense is resolved under Rule 526 and our variance application is decided under Rule 502. Please see our Answer for additional information.
