<p>ECMC Inspection Report Summary  On Wednesday 11/1/23 at approximately 1042hrs I, Inspector Adam Burns, Conducted an on-site inspection due to an incident at Redtail Gas a Plant of Fundare Resources Operating Company LLC.  Location ID #444251 in Weld County, Colorado.  I spoke to Don Harding with Burnt Mountain Services LLC and he informed me that the incident took place in the equipment storage area at the Redtail gas plant. Don informed me that the 3 man crew was heating a valve up on the portable vac trailer. Don informed me that while heating the valve to un-thaw it ignited the gas vapor within the vac trailer. This then caused the pressure to explode causing the back door hatch to be released from the locks, causing the door to hit three crew members. One crew member was hit in the shoulder possibly causing it to be dis-located, this crew member was transported by ambulance to Greeley. The second crew member was lacerated in the abdomen by the cam coupling lock and had 3rd degree burns he was transported by flight for life to Denver. The third crew member had a possible concussion and was transported to Greeley for evaluation. There was no damage to other equipment on location. A spill was released from the vac trailer due to the incident. The spill appears to be approximately 140ft in length, approximately 32ft wide near the vac trailer, and approximately 3ft across at the end of the spill.  Dene Martin-Production Superintendent &amp; Bryan Brown-VP Operations were on location with Fundare Resources Company LLC.
