During the inspection, the following compliance issues were observed:

- 1) Storage tanks do not have capacity posted
- 2) Debris in tank battery
- 3) Stormwater; refer to Stormwater section

A follow-up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
