While there, I observed that the well head sign lacked an emergency contact number and the separator manifold valves and check valves were leaking. During this inspection the following possible compliance issues were observed: Rule 605.d. with a corrective action date of 12/4/2023, Rule 608.e. with a corrective action date of 12/4/2023. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
