 While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

1. Signs/Marker - Tank label lacks required information with a CA date of 12/27/2023
2. Equipment - Open ended pipe on production tank/wildlife hazard with a CA date of 11/04/2023
3. Equipment - Open ended load line with a CA date of 11/04/2023

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with CECMC rules.
