A site investigation was conducted pursuant to COGCC Rule 911 at the THOMPSON T4N-R64W-S28 L02 Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, one soil sample was submitted for laboratory analysis of metals in soil per COGCC Table 915-1. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The COGCC Tank Battery and Produced Water Vessel Closure Checklists were utilized and filled out during the abandonment process. A photolog was submitted on the Subsequent Form 27.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

A Site Assessment was conducted on 6/2/2023 to delineate impacted media. Six soil borings were advanced in the area of impacts. BH01 was advanced at the same location as the waste characterization sample FS01 @5.5' to vertically delineate impacts at that location. BH02-BH06 were advanced surrounding BH01 to vertically and laterally delineate impacts identified at FS01 @5.5'. Soil samples were collected and analyzed for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil, arsenic EC, SAR, pH, and boron. Each of the six soil borings were converted to temporary groundwater monitoring wells. Six groundwater samples were collected and analyzed for BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, 2-methylnaphthalene, and inorganic parameters.

Based on the justification provided in the Remediation Summary section to eliminate metals and inorganics (pH, EC, SAR, and boron) as contaminants of concern, Noble will continue quarterly groundwater monitoring per the Groundwater Monitoring plan outlined in this Form 27 until four consecutive quarters of compliant groundwater results are achieved. Following four quarters of groundwater monitoring, Noble will request No Further Action (NFA) from the ECMC.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Laboratory analytical results for one of the eight decommissioning soil samples indicate hydrocarbon concentrations above ECMC Table 915-1 Protection of Groundwater Soil Screening Levels (GSSLs) but below ECMC Table 915-1 Residential Soil Screening Levels (RSSLS). Hydrocarbon compounds detected above ECMC Table 915-1 GSSLs included a combination of 1,2,4-TMB, 1,3,5-TMB, and 2-M. All ten soil samples collected during site assessment activities are in compliance with ECMC Table 915-1 GSSLs for hydrocarbon compounds.

Laboratory analytical results indicate pH was above ECMC Table 915-1 Soil Suitability for Reclamation (SSR) standards in one decommissioning soil sample (AST01@0.5'). All other samples collected during decommissioning and site assessment activities were in compliance with ECMC Table 915-1 SSR standards for pH, SAR, EC, and boron. Since the pH exceedance identified at AST01@0.5' has been fully delineated by site assessment soil borings, the pH appears to be limited to a singular point source area that will be removed during reclamation.

Arsenic was detected above applicable ECMC standards in 11 soil samples submitted for laboratory analysis. To determine if arsenic should be considered a contaminant of concern, a total of ten background samples were collected from five discrete locations and analyzed for arsenic. The average background concentration with a 1.25 multiplier applied was calculated to be 2.16 mg/kg whereas the average site assessment and decommissioning sample concentration for arsenic was calculated to be 2.03 mg/kg. Since the arsenic was observed in background soil samples at greater concentrations than in the site assessment and decommissioning soil samples, arsenic should not be considered a contaminant of concern at the site.
