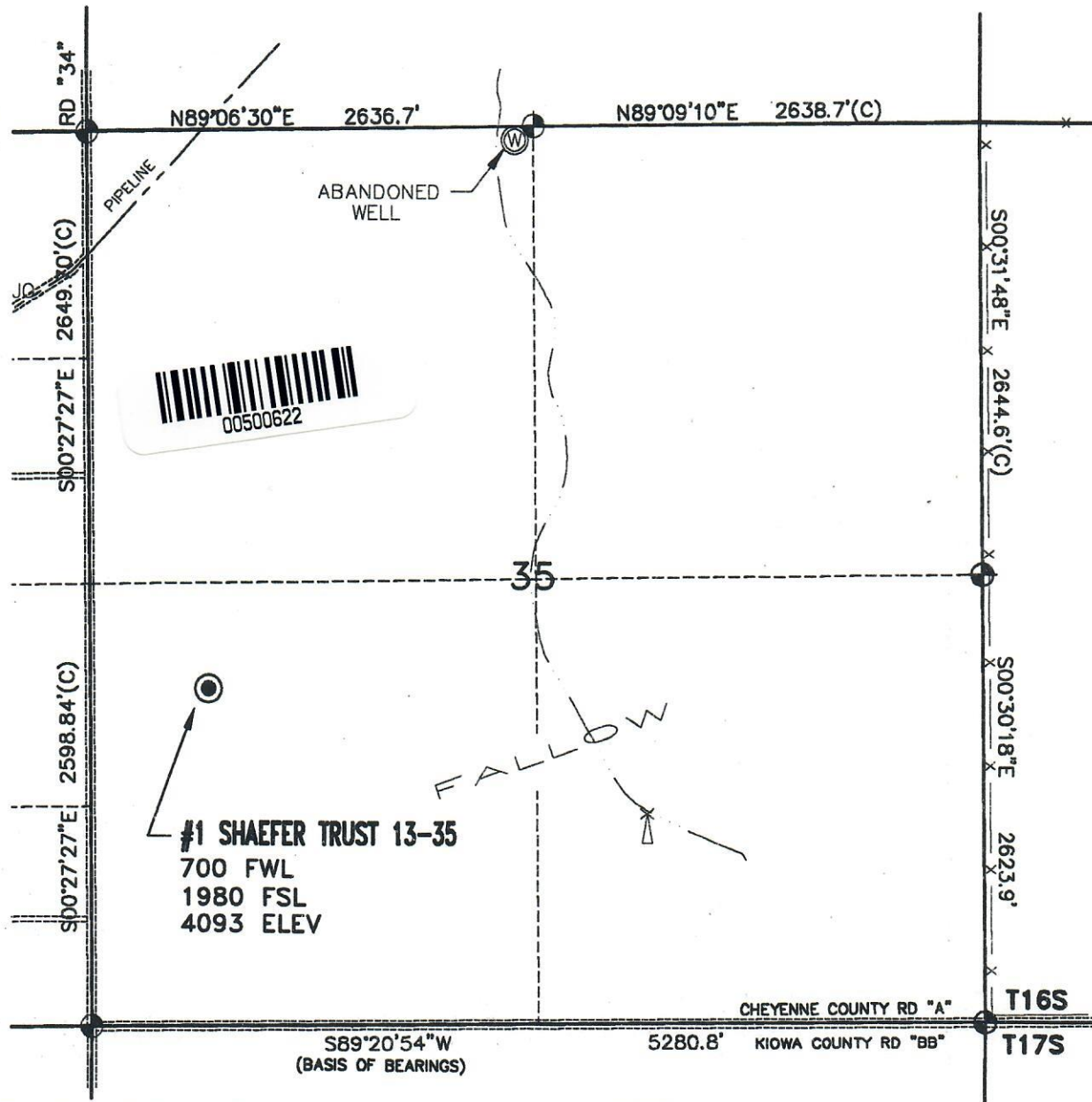


# SECTION 35 TOWNSHIP 16S RANGE 46W

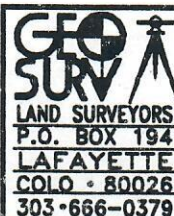
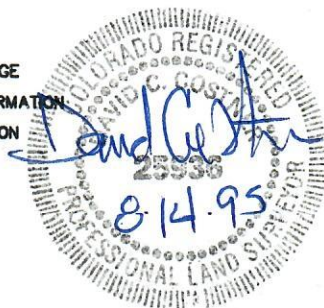

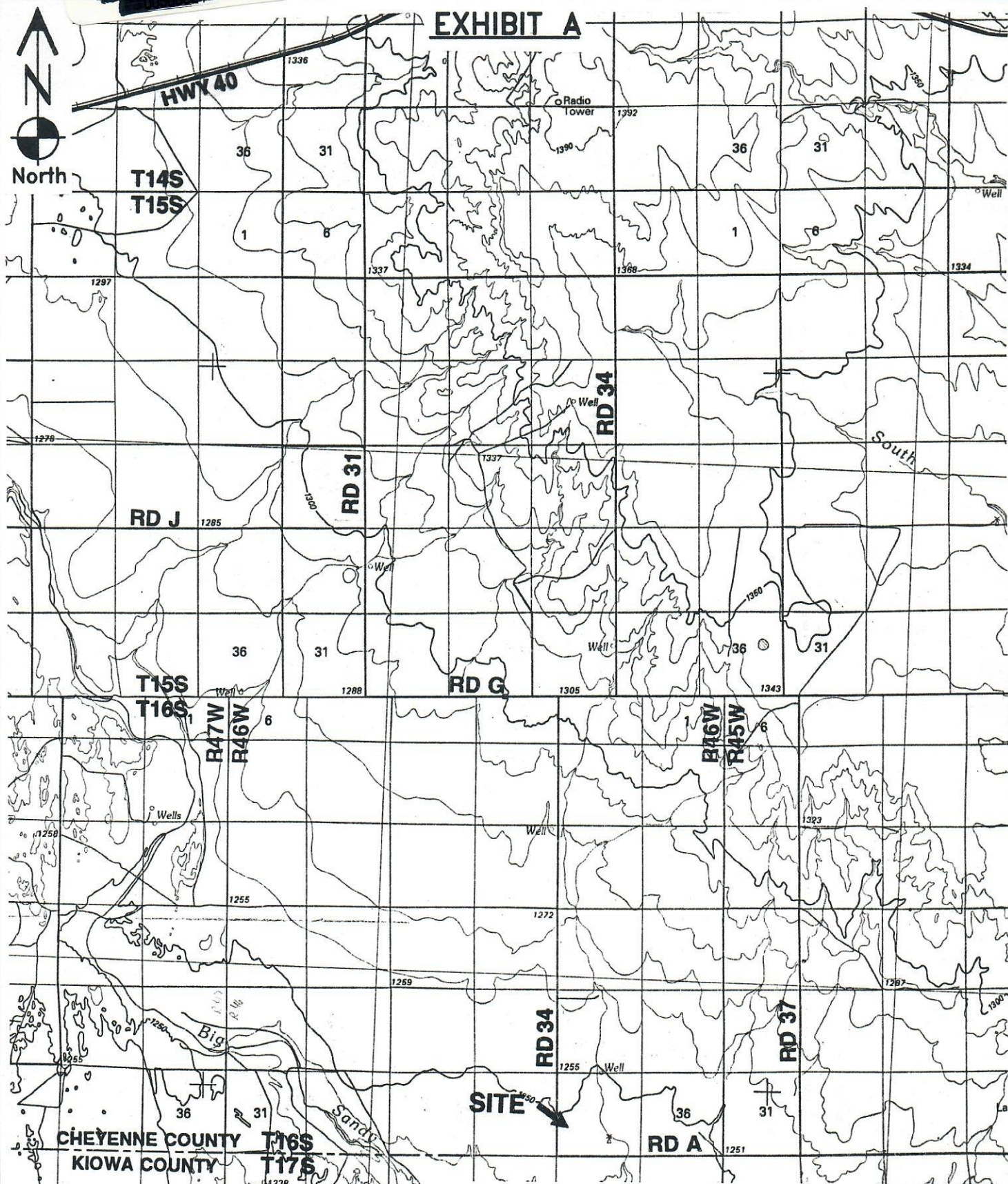
**WELL LOCATION MAP**

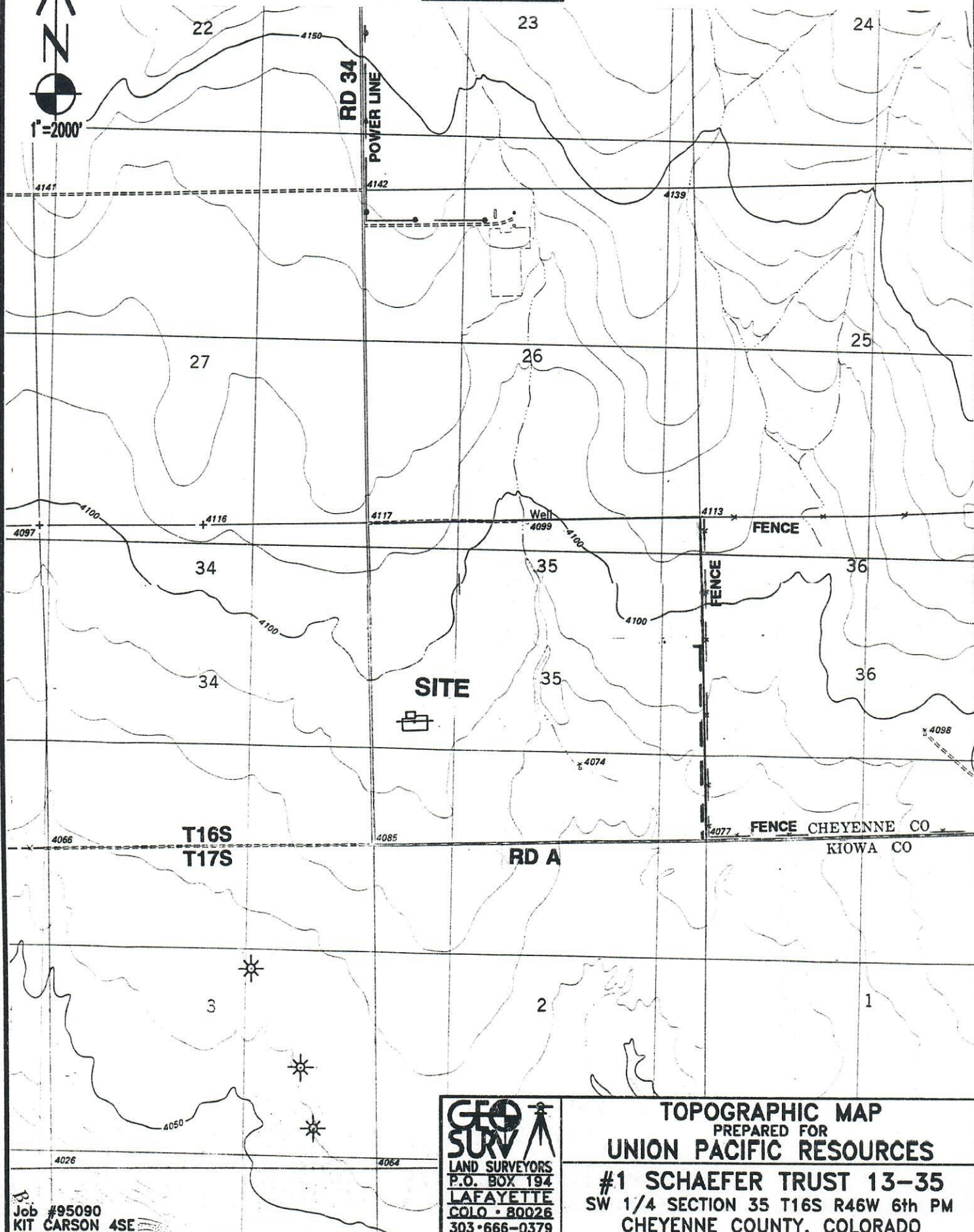

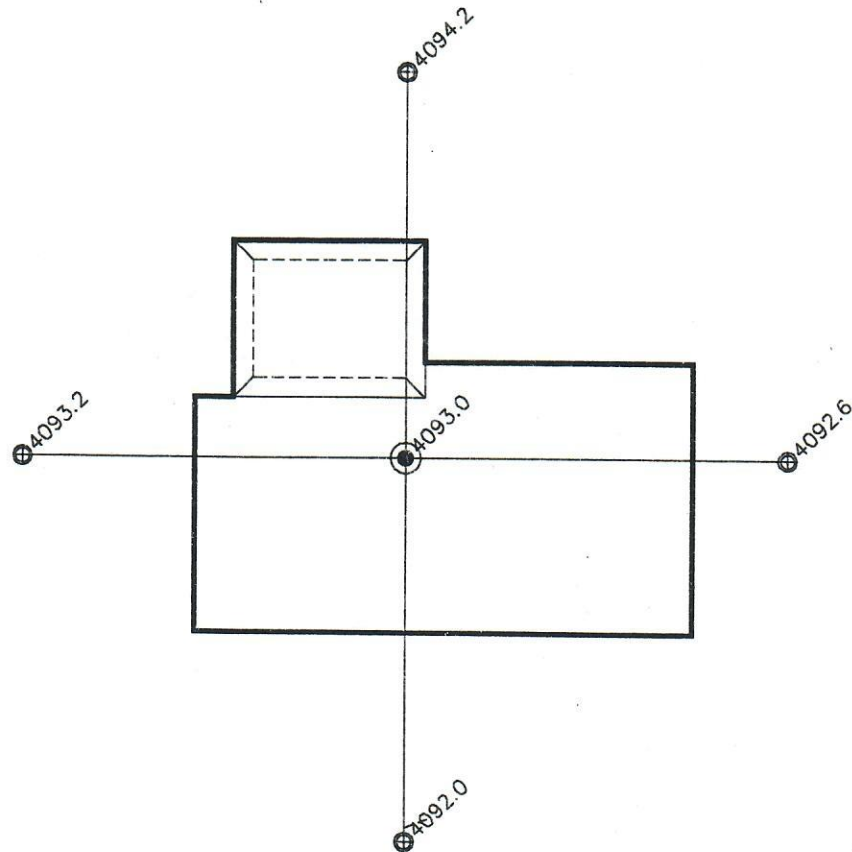
