Comment

This location does not comply with Rule 1003. It does not appear any additional reclamation activities have been performed since the previous inspection (doc #697504289). The pit and interim areas consist of areas of non-uniform vegetative cover resulting in areas of bare/exposed soils and evidence of undesirable vegetation (e.g. kochia, russian thistle and crested wheatgrass) was observed throughout, though the location appears to have been recently mowed. Additional reclamation activities are required as this location is not reflective of adjacent reference areas. Refer to attached inspection photos.

Corrective Action

Perform reclamation in accordance to Rule 1003 for the interim areas and pit area. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards. Operator shall submit a Form 4 Interim Reclamation Complete notice when the location meets Rule 1003 standards. ECMC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1003.

The location will remain out of compliance until the corrective action has been resolved.
