Comment **This location does not comply with Rule 1003. During this inspection, it was observed that the interim reclaimed areas are not progressing towards reclamation standards as the location is not reflective of adjacent reference areas. The location appears to have been recently mowed, however, there is evidence of undesirable vegetation (e.g. kochia, russian thistle and ragweed) and the topsoil stockpile has areas of bare/exposed soils. Additional reclamation activities are required. Refer to attached inspection photos.**

Corrective Action **Perform reclamation in accordance to Rule 1003 for the interim areas and pit area. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until the location meets Rule 1003 standards. Operator shall submit a Form 4 Interim Reclamation Complete notice when the location meets Rule 1003 standards. ECMC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1003.**

The location will remain out of compliance until the corrective action has been resolved.
