<p>COGCC Inspection Report Summary On Tuesday 11/7/2023 at approximately 10:00 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the PDC Energy Alva Shable 1-4 location #323599 in Weld County, Colorado. While there, I observed that the wellhead sign emergency contact number required replacement, debris at the wellhead and the battery sign producer decal required replacement. During this inspection the following possible compliance issues were observed: Rule 605.d. with a corrective action date of 12/8/2023, Rule 605.e. and Rule 606. with a corrective action date of 12/8/2023 with a corrective action date of 12/8/2023. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
