INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On July 12 through 17, 2023, flowline removal operations were completed on the flowline associated with the Palmer 14-8 wellhead. The Palmer 14-8 wellhead will be plugged and abandoned at a later date. Visual inspection and field screening of soils using a photoionization detector (PID) was conducted at 10 pothole locations along the former flowline during its removal. Soil samples were collected from the locations where the risers were disconnected at the separator (FL-B10@4') and wellhead (FL-B04@4'), and where the flowline changed direction (FL-B01@4' and FL-B06@4'), and submitted for laboratory analysis to determine if a release occurred. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data are presented in Table 1. The flowline soil sample and field screening locations are illustrated on Figure 2.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

On July 12 through 17, 2023, soil samples were collected from the locations where the risers were disconnected at the separator (FL-B10@4') and wellhead (FL-B04@4'), and where the flowline changed direction (FL-B01@4' and FL-B06@4'). The soil samples were submitted for laboratory analysis of BTEX, 1,2,4- and 1,3,5-TMB, naphthalene, TPH-GRO (C6-C10), DRO (C10-C28), and ORO (C28-C40), pH, EC, SAR, and boron using standard ECMC-approved methods appropriate for detecting the target analytes in Table 915-1. Analytical results indicated that constituent concentrations in the confirmation soil samples were in compliance with ECMC Table 915-1 standards. Soil analytical results are presented in Tables 2 and 3.

On July 12 and 14, 2023, visual inspection and field screening of soils was conducted at 6 additional pothole locations during flowline removal activities. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the soil screening locations. As a result, soil samples were not submitted for laboratory analysis from these areas in accordance with the ECMC Operator Guidance for Oil & Gas Facility Closure document. Soil sample location and field screening data are presented in Table 1. Soil analytical results are summarized in Tables 2 and 3. The soil sample and field screening locations are illustrated on Figure 2. The laboratory analytical reports are provided as Attachment A. The field notes and a photographic log are provided as Attachment B.

Laboratory results indicate that constituent concentrations in the 4 soil samples collected during flowline removal operations (FL-B01@4', FL-B04@4', FL-B06@4', and FL-B10@4') were in compliance with ECMC Table 915-1 standards. As such, no soils were removed during flowline removal operations. The flowline removal potholes were backfilled and contoured to match pre-existing site conditions.

REMEDIAL ACTION SUMMARY

Laboratory results indicate that constituent concentrations in the 4 soil samples collected during flowline removal operations (FL-B01@4', FL-B04@4', FL-B06@4', and FL-B10@4') were in compliance with ECMC Table 915-1 standards. Groundwater was not encountered during flowline removal operations. Based on the analytical and soil screening data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
