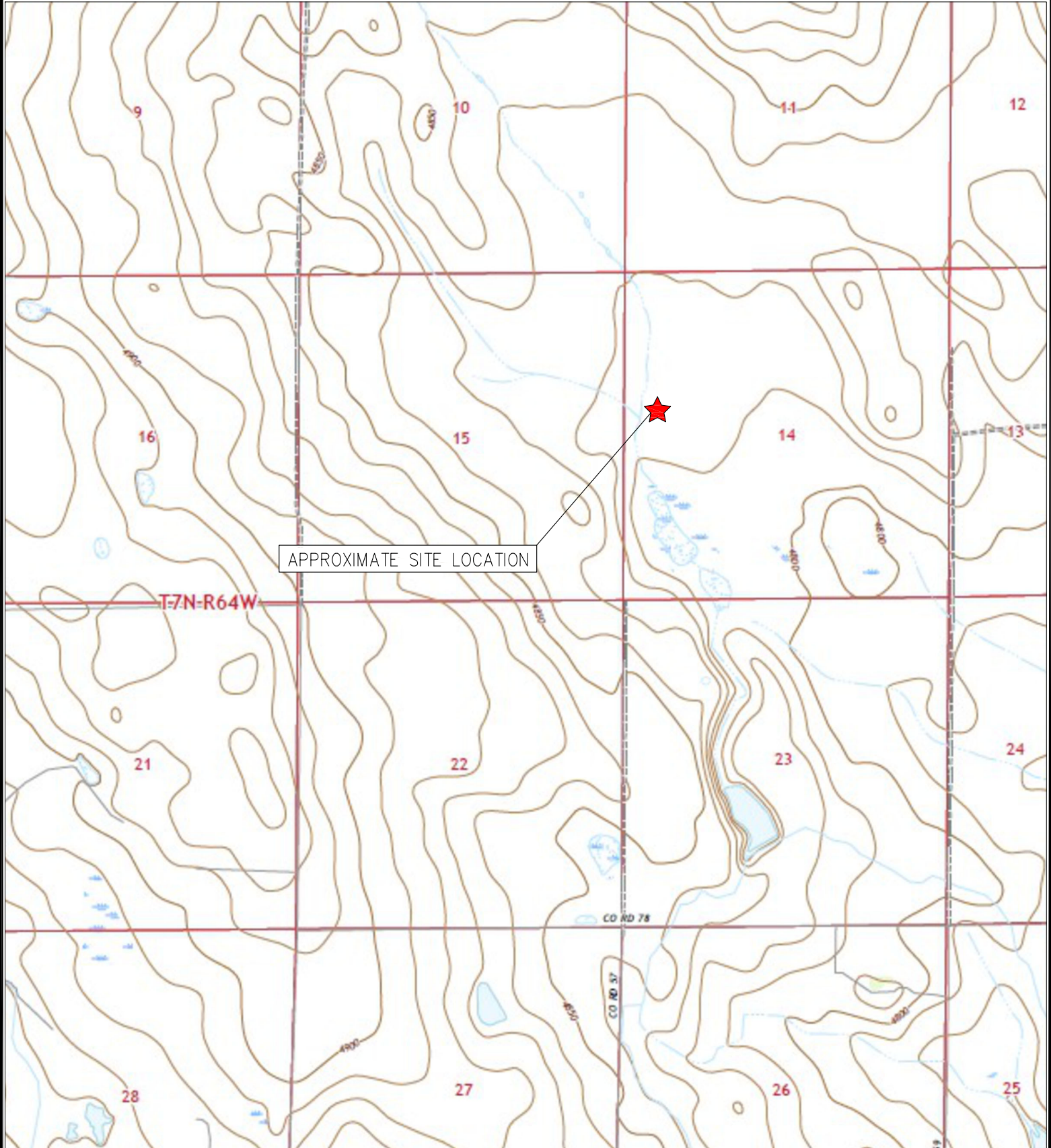
Figure 2: Aerial Site Location Map

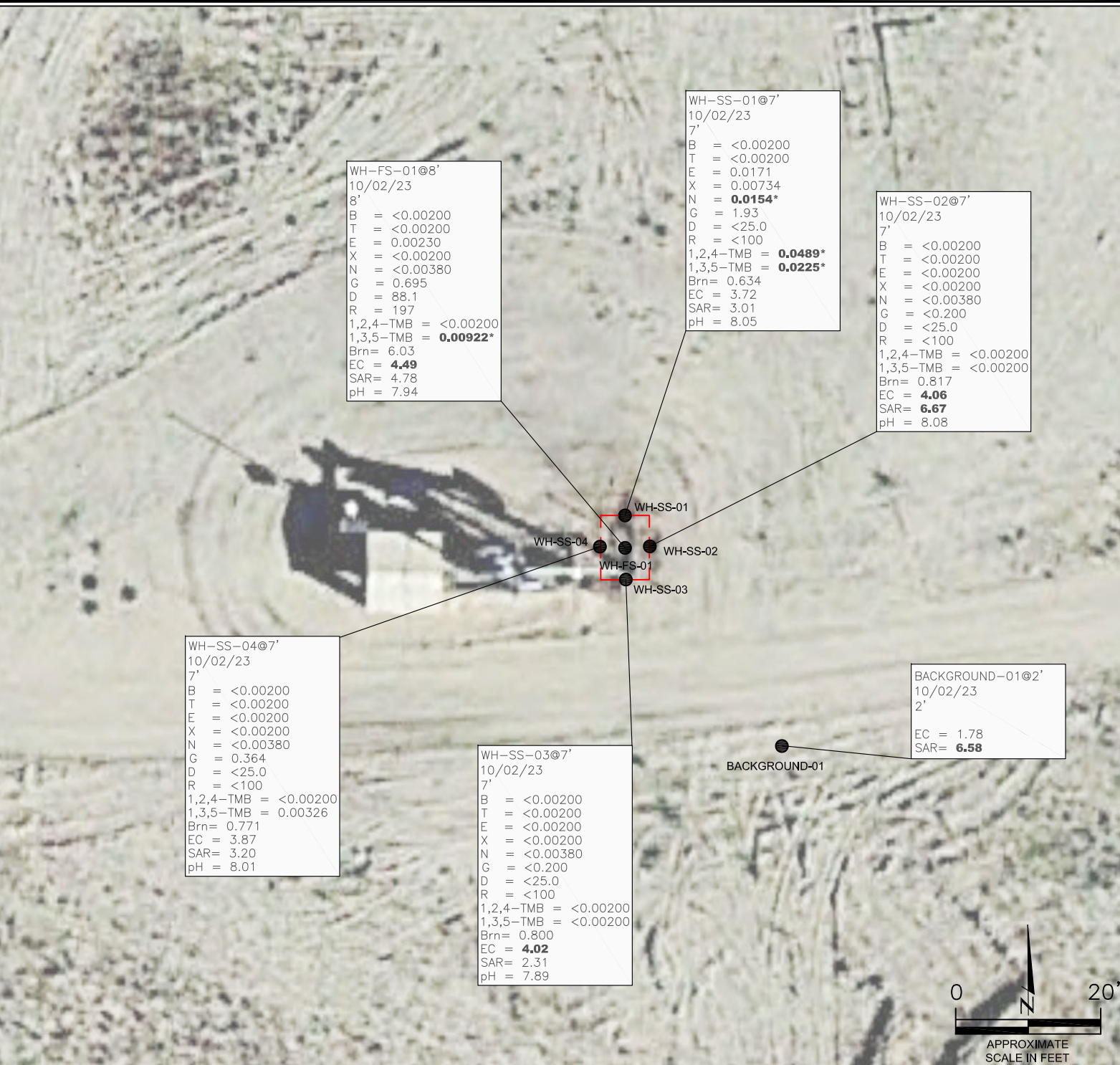

POLYCYCLIC AROMATIC HYDROCARBONS MAP

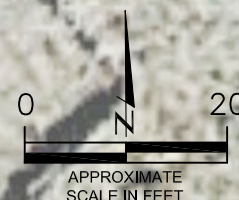

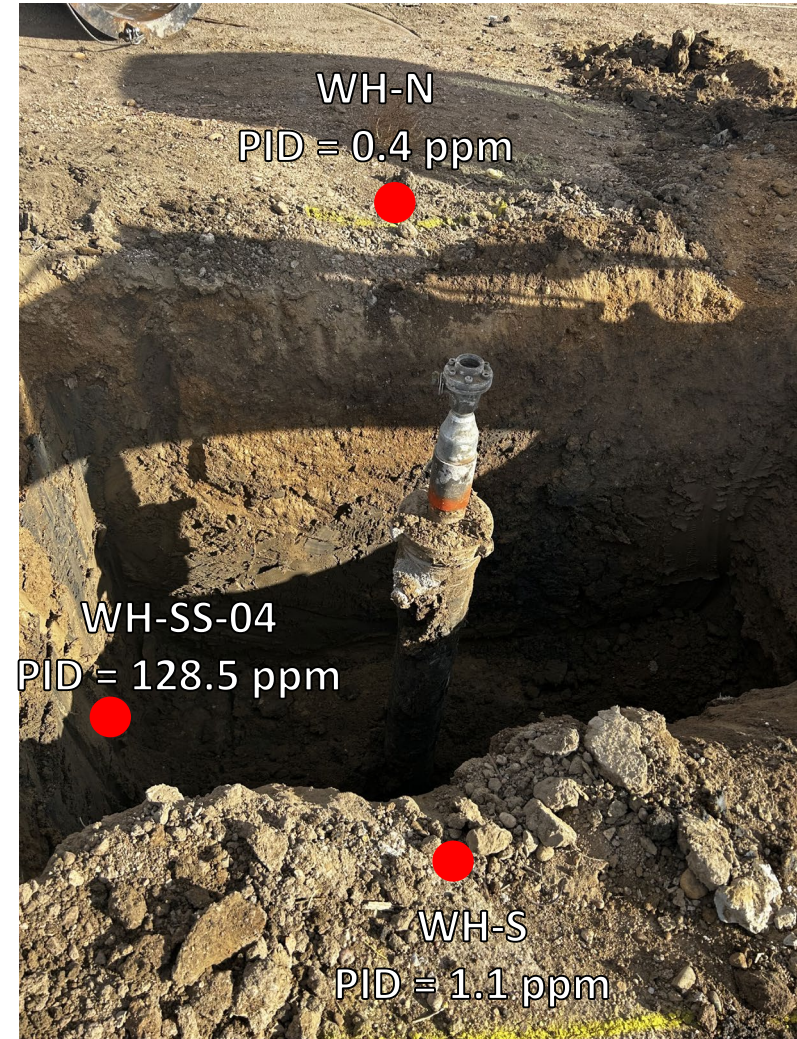
