## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SHABLE 14-25 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. The flowline was previously abandoned on 11/21/2018, and the ECMC was notified on Form 44 Document number 403216829. A historical release was identified at the wellhead based on laboratory analytical results exceeding ECMC Table 915-1 protection of groundwater soil screening levels, only.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Five (5) grab soil samples were collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

A background sample was collected from similar lithologic soil near the wellhead for pH, SAR, arsenic, barium, lead, and selenium analysis. Residual SAR, arsenic, barium, lead, and selenium values/concentrations are consistent with/less than background comparison. Additional background samples for pH analysis will also be collected.

If groundwater is observed during assessment activities, monitoring wells will be completed and samples will be collected for BTEX, naphthalene, TMBs, 1-methylnaphthalene, and inorganic compounds per ECMC Table 915-1.
