In response to the previous corrective action, Operator has performed additional final reclamation activities, which included conducting soil testing, developing a Reclamation Plan and Forest Service consultation regarding access roads. It appears the access road to the well location will remain in place. However, there was some vehicle traffic on the well location reclamation areas that could be impacting reclamation success.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards.
