On Tuesday, 11/14/2023, Inspector Kirby Burchett, conducted a routine field inspection at Caerus Piceance LLC on the USA-Piceance Creek T43X-24G well, Location #314236, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District and Wildlife Management Plan with Black Bear, High Priority, NSO, and Density Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal operations the following compliance issues were observed:

1. Separator 39 feet from wellhead.
2. Wellhead 38 feet from condensate tank.
3. No sign at tank battery.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
