The associated off location tank battery (cropland) meets Rule 1004 vegetative requirements.</p> <p>A significant portion of the well location access road has weedy vegetation and mostly established with tumbleweeds.</p> <p>Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil.
