A total of five grab soil samples will be collected, including one from pit center, and one from each side wall. Samples will be retrieved at 1 foot intervals down to 5 feet using a hand auger. Each interval will be field screened using a Photoionization Detector (PID). The interval with the highest reading will be kept and sent to the lab for analysis against Table 915-1. If all sample field screen readings are similar, and there are no visual impacts or odors indicating hydrocarbons presence, the 5-foot depth sample will be kept. Sampling Map is attached.
