The site will be visited for initial investigation of site conditions and collection of soil samples from the pit. Soil sampling will be conducted as outlined below and in accordance with Rule 915.

Soil samples will be collected from the pit center and four side walls. A hand augur will be used to collect samples from each location in 1-foot intervals to 5 feet. Each interval will be field screened with a Photoionization Detector (PID) and the interval with the highest PID reading will be retrieved and sent to the lab for COGCC Table 915-1 analysis. If field screening indicates no hydrocarbon impact and no soil discoloration or odor is present, the 5-foot sample will be submitted for COGCC Table 915-1 analysis. Sample points will be mapped with a Trimble GPS unit and used to generate a sampling map.
