Comment: The location was reclaimed in the fall of 2019. The perennial vegetation is well-established throughout most of the location. All temporary erosion controls will need to be removed once final stabilization is completed. There are two areas with less vegetation that could benefit from additional hand seeding. Overall reclamation is progressing and no erosion or noxious weed issues were observed. A follow up inspection will be performed to evaluate reclamation completeness.
