Comment:

This inspection was in response to a reclamation complete notice. Based on observations from this inspection the location has not met the reclamation requirements. There are areas along the access road and at the location that have not established a uniform perennial vegetation cover of at least 80 percent. There are undesirable weeds along the west and east side of the location which will need to be controlled. There is a perimeter fence that remains where weed debris has accumulated along the fence and the debris will need to be removed. Additional weed control and reseeding will need to be performed. Corrective action will remain out of compliance until completed.
