Please refer to inspection 708902256 conducted on 11/16/2023, previous corrective action has not been completed. Corrective action date remains 11/24/2023.
Location is within High Priority/Density/Black Bear Habitat areas/Bald Eagle Roost site & in close proximity to NSO Habitat area. Location is approximately 288 yards from Spruce Creek. While there, I observed normal production operations.

1. Equipment - Open ended load line with a CA date of 11/24/2023
