INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the FOOS C27-18 wellhead cut and cap and flowline removal. Approximately 2580' of flowline was abandoned-in-place, and future partial removal is planned for the fall or winter. The associated Form 44 document number is 403554761. So as to not disturb the other line(s) sharing the common trench, soil samples were only be taken at the start and endpoint of the flowline where the common trench exists. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead, and taken along the flowline, up to the point of the common trench, at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The ECMC will be updated in a supplemental Form 27. The wellhead was cut and capped per ECMC rules. Wellhead data will be submitted on a future F27 supplemental. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were/will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
