A site investigation was conducted pursuant to COGCC Rule 911 at the REISTAD T4N-R64W-S5 L01 Tank Battery location.

Twelve (12) grab confirmation soil samples will be collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, one soil sample was analyzed for COGCC Table 915-1 metals. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

A Site Assessment was conducted to delineate impacted media at the facility. A total of five soil borings were advanced in the area of impacts. Soil samples were collected and analyzed for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and pH, EC, SAR, and boron. Additionally, three soil samples were analyzed for COGCC Table 915-1 metals. Groundwater was not encountered during the site assessment.
