Comment **Bare soil on flowline path from wellhead to tank battery (see inspection photos). Perform reclamation per Rule 1003. Establish vegetation with total perennial, non-invasive uniform plant cover of at least 80 percent of reference area levels. Use surface owner seed mixture, or one prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage the site.**
