Produced water leak was from a Frac Tank while back flowing Raven A4 Well, Produced water spill was above grade. Cause was internal corrosion. Vac trucks evacuated remaining liquids from Frac Tank. Spill area will be water washed and all proper notifications have been made. Spill was just off of location and stayed on well access road.

A preliminary soil sample was collected on July 28, 2022 from the spill path. A total of one (1) grab sample analyzed for Table 915-1 parameters was collected at a depth of 0 to 1 foot below ground surface. Results indicate elevated SAR, EC and HSB within the impacted area.
