SUNDRY NOTICES AND REPORTS ON WELLS

INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplete or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

Well spudded 9-6-59. T.D. was 3577. Operator set 120' of 8 5/8" surface casing and cemented from top to bottom. A 6 1/4" hole was drilled below surface casing, using rotary tools and air as circulating medium. Hegwer Drilling Company, Rangely, Colo., Contractor. A slight show of oil was encountered in the Mancos shale from 2825-50 feet, but on bailing hole there was not enough to justify completion.

Operator requests permission to P & A well as follows: from T.D. to 30 feet to fill hole with mud. From 30' to surface to set cement plug and set 4" steel marker in hole and extend it 4' above ground; to fill pits and clean location.

Operator requests permission to do the above abandonment work when weather is more favorable and a rig is available.
