THE SUBJECT WELL WAS SPUDDED ON 12/12/69; 8-5/8" SURFACE CASING WAS CEMENTED AT 263' WITH 165 SACKS ON 12/15/69; 7-7/8" HOLE WAS DRILLED TO T.D. 5830'; 4 1/2" CASING WAS CEMENTED AT 5820 WITH 150 SACKS ON 1/1/70; POTENTIAL PAY INTERVAL, WAS PERFORATED WITH 2 SHOTS/FOOT FROM 5613 TO 5630 ON 1/28/70; WATER WAS RECOVERED AFTER ACIDIZING AND FRAC OPERATIONS; ON FEB. 10, 1970 REQUEST WAS MADE BY TELEPHONE AND PERMISSION WAS GRANTED TO CUT, PULL, AND RECEMENT THE 4 1/2" CASING TO TEST SHALLOW POTENTIALLY PRODUCTIVE ZONES FOLLOWING PROCEDURES AS FOLLOWS: SET CAST IRON BRIDGE PLUG AT 5600' IN THE 4 1/2" CASING, CUT CASING AT 4150', SET CEMENT PLUGS - 30 SACKS AT TOP OF 4 1/2" CASING STUB, 40 SACKS 4440' TO 4310', 30 SACK PLUG 3080' TO 3000' AS CASING IS BEING PULLED; RECEMENT 4 1/2" CASING AT 2300' PREPARATORY TO PERFORATING AND TESTING SAND ZONES IN THE INTERVAL 1750' TO 2050'. PLUGGING BACK OPERATIONS SCHEDULED TO BEGIN 2/11/70.
