A site investigation was conducted pursuant to ECMC Rule 911 at the CORNELIUS T3N-R65W-S11 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumpline(s) of any separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Before excavation of impacted soil, soil borings will be installed to delineate the vertical and lateral extent of soil impacts at the location. Confirmation soil samples will be collected and analyzed for the full Table 915 suite. If groundwater is encountered, the soil boring(s) will be improved with temporary PVC monitoring wells and sampled for Table 915 constituents in groundwater. Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site. If groundwater impacts are observed, an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECMC in a supplemental Form 27.

GROUNDWATER MONITORING

Noble Energy, Inc. proposes to install soil borings that will be improved with temporary PVC monitoring wells. One monitoring well will be installed within the source area (if possible) and additional wells will be installed to monitor up-gradient, down-gradient, and cross-gradient groundwater conditions. Each soil boring location will have the soil type logged, will be field screened with a PID, and the interval with the highest PID measurement and/or the interval directly above groundwater will be collected and submitted for analysis of Table 915-1 constituents in soil. Quarterly groundwater monitoring will be completed until four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits. Groundwater monitoring wells will be sampled and submitted to a laboratory for analysis of Table 915-1 groundwater constituents: Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), naphthalene, 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Chloride ion, Sulfate ion and Total Dissolved Solids (TDS).

OPERATOR COMMENT

The facility closure soil sample that was collected from the East wall of the former PWV excavation (PWVE01@6') was reported with exceedances for organic compounds and arsenic. Additionally, the soil sample that was collected under the former crude AST (AST01@6") was reported with a pH slightly below the regulatory limit. No other soil suitability for reclamation or Table 915-1 metals exceedances were reported for the soil samples collected during facility decommissioning. The AST01@6" sample location will be resampled for pH. Noble Energy Inc. requests that further soil sample analysis at the location include only analysis for Table 915-1 organic compounds and arsenic. If approved, additional soil sample analysis will include only Table 915-1 organic compounds and arsenic.
