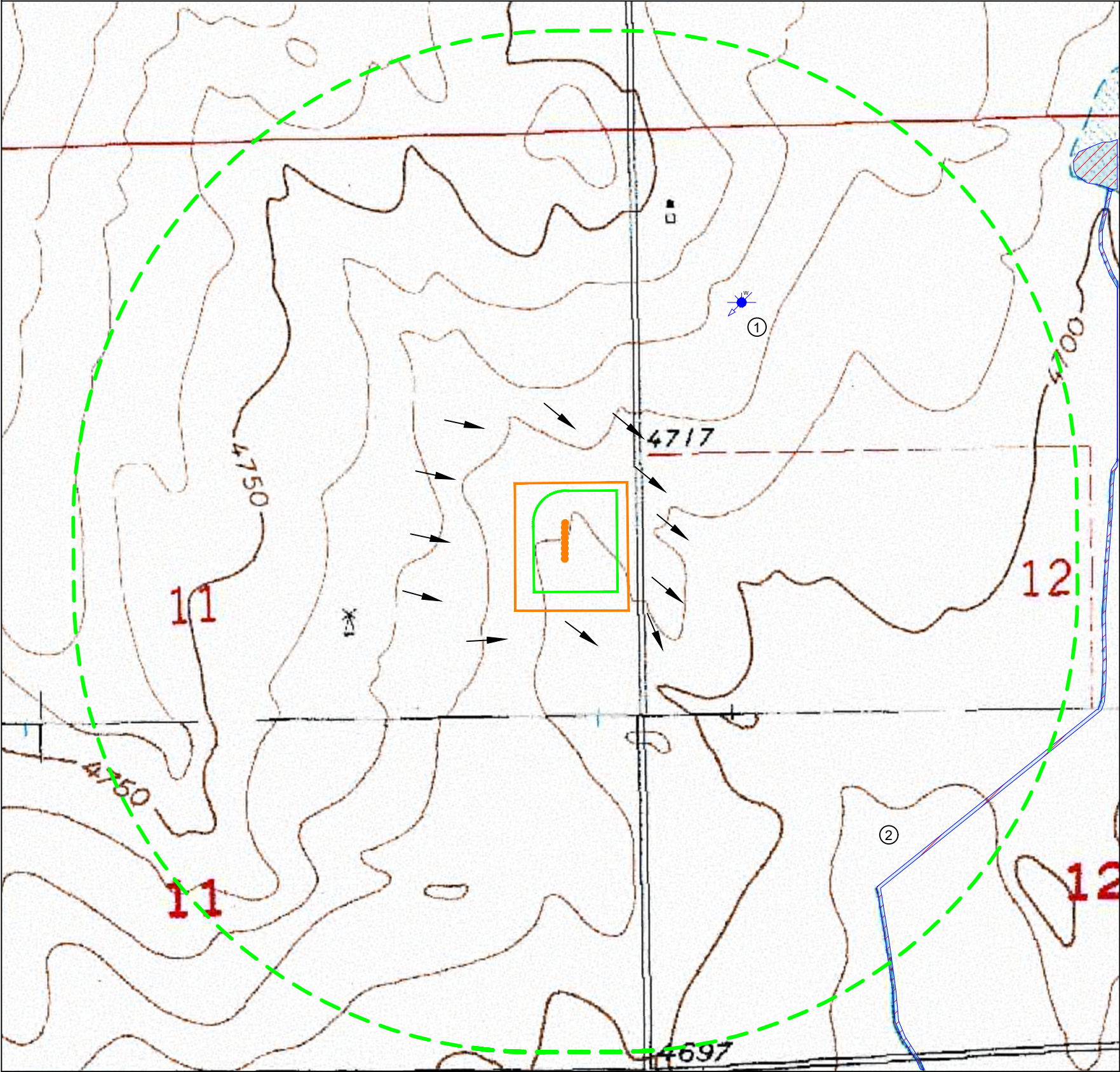


RUH STATE SOUTH PAD

2. SEASONALLY FLOODED INTERMITTENT RIVERINE WETLAND:	±2254' SE

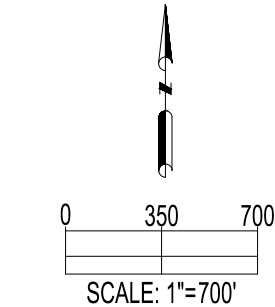
