INITIAL ACTION SUMMARY

Description of initial action or emergency response measures taken to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to summarize ongoing assessment activities conducted during the closure of the Johnson 7-24, Bohlende O SA production facility, as proposed in the Form 27 Initial dated June 21, 2023 (Document No. 403436738). Assessment activities have not yet commenced at the site.

In accordance with ECOM Rule 911.a., soil samples will be collected and submitted for laboratory analysis of the ECOM full Table 915-1 to determine if soils are in compliance. Visual inspection and field screening of soils will be conducted following decommissioning of the associated infrastructure. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1. Proposed soil sample and screening locations are provided on Figure 2.

Following facility decommissioning activities, discrete soil samples will be collected from the surfaces and excavation area(s) in accordance with ECOM Operator Guidance—Rule 911.A.(4)—Oil and Gas Facility Closure and Rules 913 & 915. If impacted soils are encountered, a waste characterization soil sample will be collected from the areas exhibiting the highest degree of impact based on visual, olfactory, and/or field screening observations and analyzed for all analytes listed in ECOM Table 915-1. Soil samples will be submitted to an accredited laboratory for analysis using standard methods appropriate for detecting the target analytes in ECOM Table 915-1. A minimum of one sample will be collected from the root zone (0-3 feet bgs) and submitted for laboratory analysis of pH, specific conductance (EC) and sodium adsorption ratio (SAR) by saturated paste method, and boron by hot water-soluble soil extract method. Please refer to the Form 27 Initial (Document # 403436738) for more details.

If groundwater is encountered during facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analysis of BTEX, naphthalene, 1,2,4-TMB, and 1,3,5-TMB, using standard methods appropriate for detecting the target analytes in ECOM Table 915-1.
