INITIAL ACTION SUMMARY

Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the HSR-LAURICE 6-1 wellhead cut and cap and flowline removal. Approximately 2016' of flowline was removed.

A grab confirmation soil sample was collected at the wellhead excavation. Five (5) grab confirmation soil samples were collected along the flowline. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
