Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

We had a produced water (injection water) spill near the Carney 35X34 well. API-05-103-07593. SENE Section 34,T2N,R102W, 6TH P.M Spill Location 40.103263, -108.824. Depth of release was approximately 4-5 feet deep. Line was isolated and spill path will be water washed and all proper notifications have been made.

**PROPOSED SAMPLING PLAN****Proposed Soil Sampling**

Preliminary soil samples were collected from the spill path on 10/6/22 and from beneath the repaired flowline on 9/7/22. A total of nine (9) grab samples analyzed for Table 915-1 parameters were collected at depths ranging from 0 to 2 feet below ground surface. Results indicate elevated SAR and EC within the impacted area at varying depths. Scout requests approval of a reduced analyte list on all future samples consisting of SAR and EC.
