	<p>This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 8/31/2020. No reclamation work has been performed; gravel remains throughout the location and access roads which have not been re-contoured or re-graded; weedy, annual vegetation was observed which includes but not limited to cheatgrass, russian, and kochia. List B CO Noxious weed, Scotch thistle, and List C species Common Mullein were observed at the well location.</p>	
Corrective Action:	<p>Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p>	Date 12/06/2023

Erosional features were observed across the well location, access road and the tank battery location. Rilling was observed on all slopes surrounding the well location, moving sediment onto and off of the well location. Rilling was also observed along the entirety of the access road as well as a major gully/blowout of the road near the midway point causing sediment to be deposited in the drainage below.
