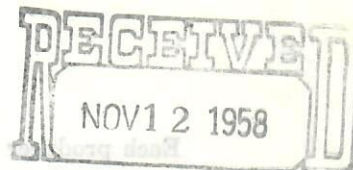

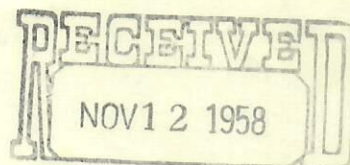

REMARKS: Western Crude Marketers, Inc., whose principal place of business is P. O. Box 1646, Denver, Colorado, and whose field address is P. O. Box 704, Sterling, Colorado, served as transporter from the Forbes-Marick lease through May 30, 1958.

Arapahoe Pipeline Company, whose principal place of business is 35 East Wacker Drive, Chicago, Illinois, and whose field address is P. O. Box 488, Brush, Colorado, became transporter from the Forbes-Marick lease effective May 31, 1958 AM.

NEW WELL COMPLETION: Forbes-Marick Well No. 4 was initially tested from 10:00 AM on April 26, 1958 to 10:00 AM on April 27, 1958 and flowed 57 BOPD, no water. After 5 days, production had declined to 4 BOPD. The well was reentered on May 28, 1958, and an additional 2 feet of casing was perforated. The well was then tested for 48 hours with production of 1.67 BOPD, 666 MCFPD, no water. The well was shut-in awaiting market for gas on June 3, 1958.
