Date of work 9-23-80

This well had been producing from the "D" Sand (4852-55') since January, 1960. Casing problems developed in this well from about 650-1950'. On 3-27-80, a service unit was moved to location. 3/4" rods were found to be parted at 3350', with the 2" tubing full of drilling mud. On 4-3-80 a 4-1/2" Baker mechanical set Model "N" cast iron BP was run on the 2" tubing, hydrotested to 6000# while going into the hole. The BP was set at 4729' (above the "D" Sand). The 2" tubing was pulled and laid down. A dump bailer was run with 1 sx of cement (approximately 10') dumped on top of the BP. The well was T.A.'d on 4-4-80.

On 9-22-80, the following work was performed: 1. Pushed Halliburton 4-1/2" plug down the 4-1/2" casing to 160'. Dumped 3 gallons cement on top of plug. Let set overnight. On 9-23-80, the 4-1/2" casing was filled from 160' to surface with 17 sxs common cement. WELL IS P.A.'d (9-23-80)
