Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the STEPHENS J31-09 wellhead cut and cap and flowline removal. This flowline was previously abandoned-in-place due to a water line and was subsequently removed. The wellhead was cut and capped per ECMC rules.

A grab confirmation soil sample was collected at the wellhead excavation and flowline change of direction. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
