On Wednesday, 12/27/2023, Inspector Kirby Burchett, conducted a routine field inspection at KT Resources LLC on the Ant Hill unit 24-43 well, Location #316314, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Parks and Wildlife (CPW) District with High Priority, NSO, Density, and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

While there during normal operations the following compliance issues were observed:

1. Random debris on pumping unit and at heater treater.
2. Oily waste and stained soil at wellhead and heater treater.
3. Gas meter annual calibration overdue.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
