INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

As part of the ECMC's ongoing investigation into production well API #05-123-16238, the ECMC has requested that Kerr-McGee Oil and Gas Onshore LP (KMOG) investigate for the potential of stray gas in the vicinity of the Johnson 7-30A well (API #05-123-20767). The Johnson 7-30A was plugged and abandoned in October of 2019. As requested, KMOG will conduct a shallow soil vapor survey in the vicinity of the former well. KMOG will also conduct a review of water resources in the area. See attached for a map of the proposed soil vapor points to be installed and sampled within the first quarter of 2024, as well as a map of all water wells located within three-quarter (3/4) mile of the former surface location of the Johnson 7-30A.

PROPOSED SAMPLING PLAN**Proposed Soil Sampling**

Pending surface access approval, KMOG proposes installing up to 19 soil vapor points in the vicinity of the former Johnson 7-30A well. The soil vapor points will be installed within shallow boreholes and will consist of 1/4 in. poly tubing packed in silica sand. The boreholes will be sealed to the surface with a minimum of 12 in. of hydrated bentonite. Once installed, the soil vapor points will be allowed to equilibrate for a minimum of 48 hours prior to screening and sampling. The soil vapor points will be screened using a GEM 5000 meter. If methane is detected on the GEM 5000, soil vapor samples will be collected into Isotubes and submitted to Isotech Laboratory under chain-of-custody protocol for gas composition (GC) analysis.
