

Details of Plan of Work: (State names of and expected depths to objective sands; Show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work.)

- 6-2-52 Spudded. Ran and cemented 8 5/8" casing at 188 feet with 110 sacks.
- 6-10-52 Drilled to total depth 5100 feet. Ran Schlumberger Survey. Cemented 5 1/2" casing at 5088 feet with 150 sacks.
- 6-16-52 Loaded hole with 35 barrels of oil. Perforated 4944-46 with 8 21-gm. jets. Bailer tested for water. Cement job okay. Loaded hole with 71 barrels of oil. Perforated 4927-44 feet with 68 21-gm. jets. Swabbed load oil, then swabbed 91 barrels of new oil in 10 hours. Ran tubing. Waiting on rods.
- 7-9-52 Installing pumping unit.
- 7-11-52 Ran rods. Waiting on engine parts.
- 7-15-52 Pumping to stabilize. No gauge.
- 7-17-52 Pumped 103 barrels of oil, no water in 24 hours. GOR 539.
Complete.
