Hello Joe,

I wanted to reach out and ask about your crop timing for the larger pivot in the field off of CR 21. I know you usually have an array of produce. We have two wells on our workover rig schedule which are shown in the attached PDF.

We would like to schedule to plug and abandon the Yamaguchi 33-37. This is are producing well operated by Kerr-McGee. Is there a time frame that avoids crops and maintenance?

We need your permission to locate the Yamaguchi R Clarke P27-9. This well was operated and plugged by Noble, but it doesn't meet the requirements for new wells to be drilled in its proximity. We would like to work with you to locate the well using a magnetometer. Once the well is located, we will dig to expose the well casing and re-enter the well to plug it more efficiently. We would also work to avoid your crop timing for the re-entry work.
