OPERATOR COMMENT

This Form 27 is being submitted as a quarterly update for the Chateau 34-14 pit remediation Project # 24452. No additional remediation activities occurred in Q4 due to hunt restrictions agreed upon with the landowner which include no heavy machinery in the area during hunting season. ENR is requesting a modification to the remedial action plan to include removal of affected soils and offsite disposal at the Trinidad Landfill. ENR will conduct these remedial actions in Q1 of 2024 accompanied by additional soil sampling. ENR will continue to provide updates on a quarterly basis. Q3 soil sample results are attached with modified report displaying Calcium, Magnesium, and sodium levels.
