General Comment:

NOTE: Physical inspection was conducted by Alex Fischer, due to technical issues inspection manually entered by Kari Brown.

On January 3, 2024, at approximately 12:45 ECMC Environmental Supervisor Alex Fischer conducted an inspection of the KPK Dwinell Tank Battery and Location. Weather was sunny, 7 degrees Fahrenheit, and there was approximately 4 to 6 inches of snow on the ground.

ECMC Staff observed an on-going release at the approximate 4" manifold going from tank to tank on the two (2) westerly 500 bbl, fiberglass produced water tanks. The release was a steady drip. An attempt to stop the leak was apparently made by the operator, as there was some type of tape placed on one of the tanks and manifold where it was leaking.

At approximately 12:59 ECMC Staff called the emergency contact number (303-825-4822) posted on Location. A Lilly (she said she was on payroll for KPK) answered the call. ECMC Staff explained who he was, the Location, and the situation.

At approximately 13:02, Lilly transferred the call to Laura. ECMC Staff explained who he was, the Location, and the situation. Laura stated that she would contact the KPK field office. ECMC Staff stated that he would stop by the field office to see if Jeff Boxley was there.

At approximately 13:20, ECMC Staff stopped in at the KPK field office. Juan with KPK was present and stated that Jeff had just left. ECMC Staff explained the situation and that the release needs to be addressed ASAP. Additionally, ECMC Staff explained to Juan to let KPK Denver know that a spill/release report will need to be filled. Juan stated that he would call Jeff.

At approximately 13:55 ECMC Staff was contacted by Jeff B. Jeff stated that he was in Laramie, Wyoming and he would return yet today (1/3/2024) to address the release and would also get a spill/release report submitted.
